SUBJECT:

Waived Requirement for the Issuance/Renewal of Certificate of Inclusion (COI) of Blood Service Facilities for the Year 2021

Pursuant to Department Memorandum 2016-0448 entitled, "Guidelines on the Issuance of Certificate of Inclusion to Blood Services Network" described Certificate of Inclusion (COI) as part of the licensing/authorization for all Blood Service Facilities actively participating in the network and complying with policies, guidelines, and standards.

One of the documentary requirements in the issuance of COI for Hospital Blood Banks with additional functions and Blood Centers is participation in the National External Quality Assurance Scheme (NEQAS) with Research Institute and Tropical Medicine Transfusion Transmissible Infections-National Reference Laboratory (RITM TTI-NRL) and National Kidney and Transplant Institute Immunohematology- National Reference Laboratory (NKTI IH-NRL).

However, COVID-19 pandemic has greatly affected the normal operations, scheduled trainings and test events of NRLs which included cancellation of NEQAS for 2020 in the abovementioned NRLs. Thus, the Health Regulation Team released Department Circular No. 2020-0306 (Annex A) dated 14 July 2020 entitled, "Waived Requirement for the Renewal of License to Operate a Clinical Laboratory for the Year 2021." Due to the cancellation of NEQAS for 2020, participation of Blood Service Facilities to NEQAS is hereby waived as a requirement for the issuance/ renewal of COI for 2021.

Waived Requirement for the Renewal of License to Operate a Clinical Laboratory for the Year 2021

Pursuant to Department Memorandum No. 2009-0086-B, dated September 8, 2014 titled "Implementation of External Quality Assurance Program (EQAP) as a Regulatory Requirement for Licensing Clinical Laboratories", all clinical laboratories shall participate in the National External Quality Assessment Scheme (NEQAS) administered by designated National Reference Laboratory (NRL) or other local and international EQAP approved by the Department of Health. A Certificate of Participation in NEQAS is required for the renewal of the License to Operate (LTO) of clinical laboratories.

A Memorandum dated November 28, 2019, titled "Lifting of the Moratorium on the Initial Issuance of License to Operate for a Free Standing Clinical Laboratories Nationwide", was issued so that laboratories can continuously operate even if they failed to participate in the EQAP.

However, the current COVID-19 pandemic greatly affected the regular operations of the NRLs, such that carrying out of the scheduled test events have been cancelled or delayed. (ANNEX)

In view of the foregoing, the licensing requirement for the NEQAS 2020 Certificate of Participation / Certificate of Performance issued by the designated NRLs is hereby *WAIVED* for the 2021 renewal of LTO of a clinical laboratory.

Good day!

The global crisis of COVID-19 pandemic has greatly affected the regular operations of the NRLs. Financial and human resources of the NRLs were diverted to the COVID-19 response as priority.

The Committee on NRL has written a letter to your office dated March 19, 2020 requesting for the extension of the deadline of the National External Quality Assurance Scheme (NEQAS) from the regular deadline of May 31, 2020 to July 31, 2020.

However, with the continued response, three (3) of the NRLs have determined that it will not proceed its EQA event for 2020. A Certificate of Enrollment shall be issued before September 30, 2020 for those who have paid their NEQAS fees.
